**Enter for all 2, 3 & 4 year olds.** Hours at setting include any funded hours + any sessions that may be paid for and/or extra hours that can be attracted under the extended free funded hours allowance (not relevant to 2 year olds). Basically, the total number of hours spent at the establishment.

Enter to 2 decimal places

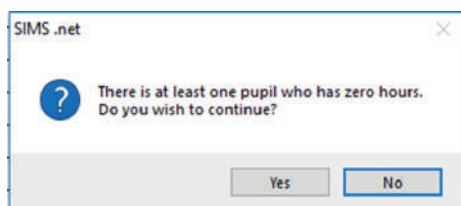

**All 2, 3 & 4 year olds** are all entitled to up to 15 hours free funding. (4 year olds with no 30 hour code can have up to a maximum of 25 hours).

This can be over 2 providers – only enter what is provided by your establishment.

The number entered needs to be between 0 and 15 – do not leave blank. Enter to 2 decimal places

You will get a message to accept if any 0's have been entered when you click save.



Funded hours and hours at setting are hours spent in education provision delivered by the school that are working towards the EYFS learning and development requirements as set out in the guidance.

4 year olds should not be in R if they have funded hours

**Relevant to 3 & 4 year olds only.** A 30-hour code will be given to all parents that are entitled to the extended funded hours provision. The 11-digit number must be entered. Don't forget to enter the number of extended hours.

4

**Relevant to 3 & 4 year olds only.** The extended funded hours can only be a maximum of 15 (enter between 0 and 15) and should only exist if there is a 30-hour code that has been entered.

Any additional EDUCATIONAL hours that a parent pays for would be recorded in the total figure in the Hours at Setting Column only the extended free entitlement is recorded in Extended Funded Hours column. Enter to 2 decimal places.

**Relevant to 3 & 4 years olds only.** DAF – Disability Access Fund – enter either Yes or No.

DAF is an additional amount of money that a provider can get and can only be paid to one provider even if the parents split their funded hours over 2 settings. The parents are responsible for nominating one establishment to get the DAF funding.
